## **Safeguarding Children and Young People in Football Child Protection Revised August 2010**

Eastbourne Borough Youth Football Club acknowledges its responsibility to safeguard the welfare of every child and young person who has been entrusted to its care and is committed to working to provide a safe environment for all of its members. A child or young person is anyone under the age of 18 engaged in any club football activity. We subscribe to The Football Association's Child Protection and Best Practice Policy and Procedures, Safeguarding Children and Young People in football (revised edition 2006) and endorse and adopt the Policy Statement contained in that document.

### **The key principles of the Eastbourne Borough Youth Child Protection Policy are that:**

- The child's welfare is, and must always be, the paramount consideration
- All children and young people have a right to be protected from abuse regardless of their age, gender, disability, culture, language, racial origin, religious beliefs or sexual orientation.
- All suspicions and allegations of abuse will be taken seriously and responded to swiftly and appropriately
- Working in partnership with other organisations, children and young people and their parents/carers is essential.

We acknowledge that every child or young person who plays or participates in football should be able to take part in an enjoyable and safe environment and be protected from poor practice and abuse. Eastbourne Borough Youth Football Club recognises that this is the responsibility of every adult involved in our club.

Eastbourne Borough Youth Football Club has a role to play in safeguarding the welfare of all children and young people by protecting them from physical, sexual or emotional harm and from neglect or bullying. It is noted and accepted that The Football Association Regulations applies to everyone in football whether in a paid or voluntary capacity. This means whether you are a volunteer, match official, helper on club tours, managers, coaches, club official or medical staff.

We endorse and adopt The FA's Child Protection and Best Practice Guidelines for recruiting volunteers and will:

- Develop a role profile
- Request identification documents
- Conduct interviews before appointing
- Undertake a FA CRB Unit Enhanced Disclosure for all managers, coaches and assistants in line with FA guidelines

All current Eastbourne Borough Youth Football Club members with direct access to children and young people have been required to complete a CRB Enhanced Disclosure via The FA CRB Unit. If there are concerns regarding the appropriateness of an individual who is already involved or who has approached us to become part of Eastbourne Borough Youth Football Club guidance will be sought from The Football Association.

**FA guidelines on Criminal Bureau Checks:**

It is noted and accepted that The FA will consider the relevance and significance of the information obtained via The FA CRB Unit and that all decisions will be made in the best interests of children and young people.

It is accepted that the FA aims to prevent people with a history of relevant and significant offending from having contact with children or young people and the opportunity to influence policies or practice with children or young people. This is to prevent direct sexual or physical harm to children or young people and to minimise the risk of 'grooming' within football.

Eastbourne Borough Youth Football Club supports The FA's Whistle-blowing Policy. Any manager, coach, adult or young person with concerns about a colleague can whistle-blow by contacting any member of Eastbourne Borough Youth Management committee.

Eastbourne Borough Youth Football Club has appointed a Club Welfare Officer (CWO) in line with The FA's role profile and completion of the Child Protection and Best Practice Workshop. The post holder will be involved with designated persons training provided by The FA. The CWO is **the first point of contact for all club members and parents/carers** regarding concerns for the welfare of any child or young person. They liaise directly with the County FA and league Child Protection Officer and will be familiar with the procedures for referring any concerns. They will also play a proactive role in increasing an awareness of poor practice and abuse amongst club members. We acknowledge and endorse The FA's identification of bullying as a category of abuse. Bullying of any kind is not acceptable at our club. If bullying does occur, all players or parents/carers should be able to tell and know that incidents will be dealt with promptly. Incidents need to be reported to the Child Welfare Officer or member of the committee or alternatively in cases of serious bullying contact the County FA Child Protection Officer.

Codes of conduct for managers, coaches, players, officials and parents/carers and officials have been implemented by Eastbourne Borough Youth Football Club. In order to validate these codes of conduct the club has clear sanctions to deal with any misconduct at club level and acknowledges the possibility of potential sanctions which may be implemented by leagues or the County FA in more serious circumstances. All prospective members will be informed of these codes.
